Chief's Report: Working with the solar farms to assistance the district with brush truck project (TPE Development, LLC has

agreed to donate \$100,000.00 and \$10,000.00 from [Indiana Ave and Western Ave] remaining \$20,000.00 will be received in 2025). Open House was well attended; hot dogs were donated by Peoria Packing in Grant Park. Lt Welsh lead crews during Fire Prevention Week and visited all grade levels, along with the Co-op Center, Learning Center and library. FEMA SAFER grant was denied officially. Grant updates, met with Biesterfeld farms to discuss district needs for agricultural rescue equipment (waiting to hear back), fuel system upgrade was completed, we now have access. Working with Air Methods, who manages Life Star and UCAN medical helicopters. Beecher Blessing distribution date is December 14. 2025 Board Up Service applications have been posted. NFPA 855 stationary energy storage systems (battery facilities and solar facilities)
